

**1) Purpose of data processing:** The Data Controller collects your personal data (name and surname, date and place of birth, residence and citizenship) as well as a copy of your identification document in order to verify your identity and therefore in order to verify your possession of the requirements of the General Conditions of Contract of the Data Controller to take advantage of a reduction in the purchase price of a ticket. The treatment takes place in order to protect the legitimate interests of the Data Controller.

In ascertaining your identity, the Data Controller uses an external company (AriadNEXT LLC with registered office at ZAC des Champs Blancs, 1219 Avenue des Champs Blancs, F-35510 Cesson-Sévigné), duly appointed as Data Processor pursuant to Art. 28 GDPR.

**2) Processing methods:** the processing is carried out automatically with the help of electronic instruments.

**3) Data transfer and mandatory consent:** The treatment provided, having the purpose of protecting the legitimate interests of the Data Controller, does not require any consent from the person concerned. However, you have the right to object to the processing of your data by sending an email to [dpo@dolomitisuperski.com](mailto:dpo@dolomitisuperski.com).

**4) Communication and dissemination:** Those in charge of data processing and previously authorized external collaborators may become aware of the personal data provided. The analysis and processing of data may also be carried out with the help of third-party companies that, however, may not use such data on their own behalf.

**5) Personal data retention period:** In case of purchase of the ticket your personal data (name and surname, date and place of birth, residence and citizenship) are kept for a maximum period of 3 years from the date of purchase and then irrevocably deleted or made anonymous. The copy of your identification document is kept for a maximum period of one month from the time of submission and then irrevocably deleted or made anonymous.

**6) Exercising your rights:** the GDPR guarantees the right to access any data concerning yourself at any time, and to obtain copies of said data or correct or complete it if inaccurate or incomplete. It allows you to prevent or restrict processing, where the conditions are met, to oppose its processing for reasons related to your particular situation and to request the portability of your data, where processed automatically, following your consent or for the implementation of the contract. You also have the right to withdraw your consent if required, without prejudice to the lawfulness of the processing and based on the consent given prior to the withdrawal. Finally, it remains firmly within your rights to contact the Privacy Authority, including through the submission of a complaint where deemed necessary, for the protection of your personal data and your rights.
